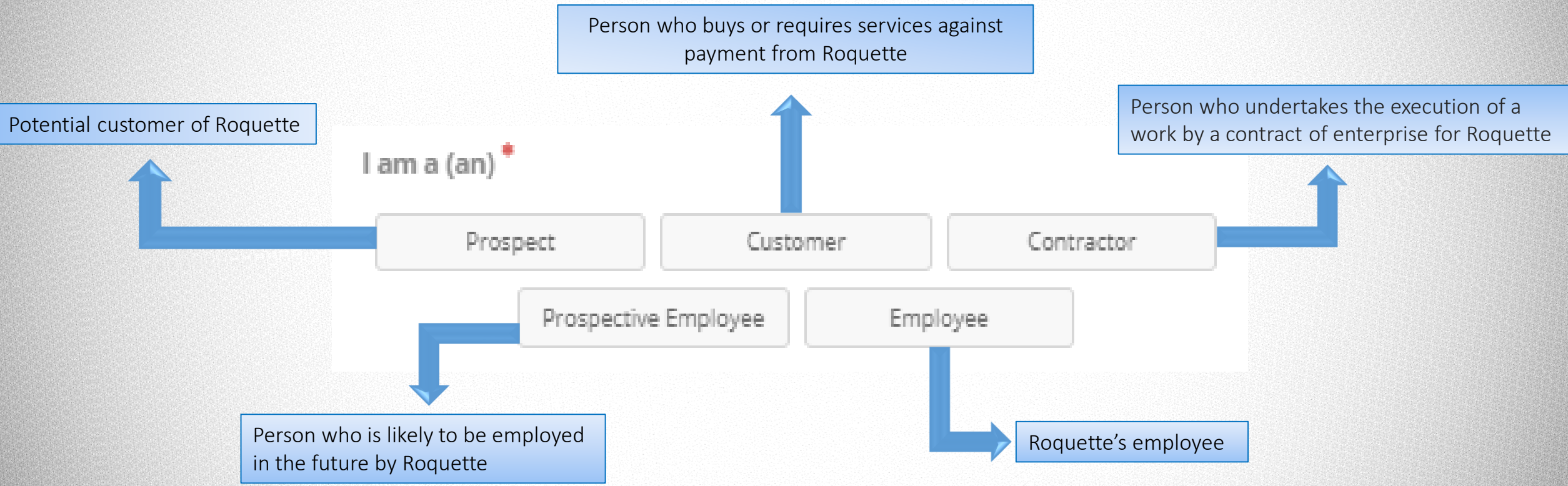

Review Automated Decision

You have the right to ask an organization to erase personal data about you.  
**Article 17 GDPR**

People's rights are strengthened when a fully automated decision is taken against them: specific information must be provided to them and they have the right to challenge the decision.  
**Article 22 GDPR**

You may request the correction of inaccurate or incomplete information about you. It allows you to prevent an organization from using or distributing incorrect information about you.  
**Articles 16 and 19 GDPR**

Data Portability

You can object at any time to an organization using some of your data.  
**Article 21 GDPR**

The right to portability gives you the ability to recover some of your data in a machine-readable format.  
**Article 20 GDPR**

You can ask an organization if it has data about you and ask for it to be sent to you for verification.  
**Article 15 GDPR**

You have the right to limit the way that an organization uses your data.
